- A. Applicants must be Edgar County residents of a Protestant religious faith enrolled as an undergraduate at one of the following institutions during the coming school year: Eastern Illinois University, Millikin University, University of Illinois or DePauw University.
- B. Awards are for one year only and can be revoked if the recipient engages in any disruptive or coercive act or participates in any non-peaceful demonstration against the authorities or management of the university. Students are not eligible to receive this award more than four (4) times.
- C. Applications for this award for the 2023-2024 school year must be on this form only, filled out in its entirety, signed and mailed to the above address between May 1 and June 1, 2023. Your application will be ineligible if dated other than between May 1 and June 1, 2023. Applications must contain original signatures on page 3 (not copies) and all information must be current as of date of mailing. Applications that do not conform to this requirement will not be considered. In the interest of legibility, we encourage you to use the bank's online PDF editor at bankprospect.com/community/scholarships/.
- D. An *official transcript* of <u>ALL</u> college and university grades through the <u>2022-2023</u> school year <u>must</u> accompany this application. However, if an official transcript of your <u>2023</u> spring semester grades is not available at the time you make this application, you are then <u>required</u> to submit a spring grade report or internet grade report *in addition to your official transcript*. If the transcript requirement is not complete, your application will not be considered.
- E. Please include the first page of your parents' 2022 Federal Income Tax Return. If you are independent, please provide the first page of your 2022 Federal Income Tax Return. If the tax return requirement is not complete, your application will not be considered.
